Public Safety Engagement:

Top 3 Responses – What would make your community safer?

- 1. More lighting in streets and public spaces
- 2. Pedestrian/traffic safety
- 3. Youth programming/services
- (326) SALC Youth Ambassador surveys
- (4) Pop-up Activities- (150) community members reached
- (2) Community Meetings- 1 in Spanish & 1 in English – (70) community members reached





What is Public Safety?

Public safety refers to the protection of the general public from crimes, disasters, and other potential dangers



KEY INFORMATION

• Since 2007, violent crime has been reduced about 40%.

- In 2018/19, 73% of SUHSD ninth graders reported feeling safe or very safe in their neighborhood.
- Between 2009 and 2018, sixty-two (62) people have died in traffic accidents.
- Calls to the Fire Department increased from 8,000 calls per year in 2002 to 16,000 calls per year in recent years.






Draft 2023-2031 Housing Element

Goal 1: Increase Housing Supply and Opportunities for All









- Incentivize/support production
- Encourage/facilitate ADUs and other types
- Update General Plan/Zoning





Goal 2: Provide Tenant Protections







- Develop tenants' rights programs and support
- Provide education and connect tenants to legal services
- Fair housing outreach





Goal 3: Access to Safe and Health Housing for all Residents



- Promote rehabilitation of housing*
- Improve the quality and condition of rental housing
- Promote sustainable and healthy housing





Goal 4: Advance Housing Affordability and Opportunity at all Income Levels





- Facilitate production of affordable housing
- Connect residents to financial resources (i.e. first-time homebuyer program)
- Provide assistance to special populations
- Provision of housing and services for unhoused residents





Goal 5: Stabilize and Support Neighborhoods

- Collaborate with residents to improve neighborhoods
- Leverage code enforcement strategies
- Encourage preservation and restoration of historic neighborhood resources
- Work to reverse patterns of discrimination
